#### A. THE COMMISSION

The J. William Fulbright Commission for Educational Exchange in the Slovak Republic is a bi-national, not-for-profit organization, whose mission is to promote mutual understanding and cooperation between the people of the United States of America and the Slovak Republic through educational and cultural exchanges.

The Commission was established by an executive agreement between the Government of the Slovak Republic and the Government of the United States of America in 1994 (319/1994 Coll.). The subsequent agreement signed in 2005 (98/2005 Coll.) was amended in 2017 (303/2017 Coll.). In 2017, the Slovak authorities started issuing national visas to Fulbright scholarship recipients and their dependents who have been exempted from visa fees since

The main responsibilities of the Commission are as follows:

- administer grants and fellowships for U.S. and Slovak nationals to study, research, or lecture;
- identify and select the best candidates in both countries and engage them in academic exchanges within the highest standards of the Fulbright Program;
- identify fields in which mutual cooperation is desirable to further develop and increase expertise in particular fields;
- extend activities by establishing and supporting cost sharing programs with participating institutions;
- spread awareness and provide information about study and research opportunities in the United States.

In addition to the administration of the Fulbright Program, the Commission is the only official institution in Slovakia certified to provide accurate, comprehensive, and current information about studies in the U.S. through its educational advising center EducationUSA, which is part of the worldwide educational advising network of the U.S. Department of State.

The Fulbright Commission is governed by the bi-national **Board of the Commission** which oversees the operation and activities of the Commission. The Minister of Education, Science, Research and Sport of the Slovak Republic appoints Slovak Board members and the U.S. Ambassador to the Slovak Republic appoints American Board members. Both serve as Honorary Co-Chairpersons of the Board of the Commission.

The Board has the responsibility for setting long term goals and priorities of the program, program activities, selection and nomination of grantees, and coordination of finances of the Commission.

## B. FULBRIGHT AWARDS

The Commission administers a variety of awards for both U.S. and Slovak citizens based on an open, merit-based competition and takes into account recommendations of selection committees focusing on professional skills, academic achievements, financial means available, and other program requirements; and announces the final nomination of Fulbright grantees.

The academic year 2022-23 had a standard cohort selected the year prior. The total number of participants in Fulbright programs administered by the Commission reached 32.

# 1. Fulbright Student Program

Slovak and U.S. graduate students can apply for 6 to 9 month scholarships to carry out independent research or study at Slovak or U.S. institutions, respectively. Candidates are required to prove an outstanding academic record and submit high-quality and well-conceived projects.

Slovak applicants may conduct an independent research, and if funding available, enroll in Master's programs. Fulbright Slovak Student Program is open to any field except for clinical medicine, M.BA and LL.M. Candidates without prior extensive U.S. study experience are given preference.

U.S. applicants can pursue individual research projects under tutorial of a Slovak expert in the respective field. Knowledge of Slovak language is desirable for commensurate with the level needed in fields like political science, history, linguistics, and anthropology.

Slovak scholars who hold a Ph.D. degree (in arts and some other fields comparable professional experience is required) must include an invitation letter from the U.S. institution in their application. All areas of research or lecturing, except clinical medicine, are eligible. Candidates without prior extensive U.S. research or study experience are given preference.

# 3. English Teaching Assistant (ETA) Program

The Slovak secondary schools receive assistance in strengthening English language instructions by establishing a qualified native speaker presence. At the same time, U.S. participants gain from intensive crosscultural interaction and research opportunities.

Due to the increase of SK funds, priority has been given to the ETA program which has grown from 8 grants in 2020 to 12 grants in 2022/23. ETAs are evenly distributed among 8 regions, mostly outside the big towns and are placed in the variety of schools – grammar schools, vocational schools, public or religious schools. The ETA program is very popular and there is a high demand from Slovak secondary schools to host an ETA. The Commission obtained 140 + applications from secondary schools in the past two years. The number of US applicants is also gradually increasing.

## 6. Fulbright Teaching Excellence and Achievement Program

The Commission launched the Fulbright TEA Program in the academic year 2021-22 with the first selection in Spring 2022. The FTEA program brings international secondary-level teachers to the U.S. for a six-week professional development opportunity to take academic seminars at a host university, observe and share their expertise with U.S. teachers and students, and develop action plans to promote media literacy and critical thinking skills in their home schools, classrooms, and communities.

3 out of 4 nominated candidates were selected by the U.S. Department of State: Lenka **ZGÚTOVÁ** (principal), Daniel **GONOS** (principal), and Natália **GETTLEROVÁ** (alternate).

The program was postponed to Fall 2023. Lenka Zgútová and Daniel Gonos have been placed at the University of Wisconsin-Madison and Natália Gettlerová at the University of Northern Colorado.

The project also involves piloting immersive storytelling and arts experiences in Slovakia and fostering reflective engagement on the climate crisis and individual roles in finding solutions.

## 3. Ronald and Eileen Weiser Professional Development Award

The Weiser Award (not sponsored by the U.S. Department of State) gives opportunity to Slovak scholars to pursue short-term research visits (4 to 6 weeks) at the University of Michigan, Ann Arbor. Candidates may submit projects in any field of research or teaching with faculty partners at the University of Michigan. These awards are made possible thanks to a gift from Ambassador Ronald Weiser, U.S. Ambassador to Slovakia from 2001to 2004, and his wife, Eileen Lappin Weiser. There were no Weiser Fellows in the academic year 2022-23 as a result of the suspension of the program due to the COVID-19 pandemic. The program has been resumed in 2023.

**Adriana Duriš Adameová** from the Faculty of Pharmacy, Comenius University in Bratislava has been selected as a new Weiser fellow from September 8 to October 22, 2023.

4. Reporting Complexity: A Study Tour in the U.S. for Journalists from Central and Eastern Europe

Practicing journalists could apply for a two-week study visit to the U.S. aimed at building skills, knowledge, and awareness related to reporting on complex issues. The program was administered by Fulbright Romania.

The study tour included a combination of custom professional workshops, discussions with experienced journalists and media representatives who have relevant experience and portfolios, opportunities for networking, as well as visits to media organizations of interest in and around Washington D.C. and New York City.

The visits were conducted in two slots:

October 15-29, 2022: **Kristína Votrubová** (daily Postoj), **Otakar Horák** (daily DenníkN) November 5-19, 2022: **Martina Bolibruchová** (zmudri.sk) and **Eva Frantová** (daily SME).

# D. GRANT SUPPORTING ACTIVITIES

The Commission carries out different activities throughout the year to support Fulbright programs, grantees and alumni, such as recruitment campaigns, selections of candidates for each program, promotional and outreach activities, educational advising, and hosting or supporting events, seminars and conferences, whether on-line or inperson.

• The Orientation Program

Regular orientation seminars are being held for both Slovak and American grantees and are mandatory components of the Fulbright program.

• Orientation seminar for incoming U.S. grantees was organized in September 2022 in order to familiarize U.S. grantees with Slovak history, cultural and social background, economy, education system etc. Furthermore, a review of the terms and conditions of their grant, financial, visa, and health issues are an essential part of the orientation. A crash course on Slovak language has proven to be of importance to U.S. grantees. The Commission annually reviews and updates the program in order to implement the guidance and protocol for a variety of possible crisis situations, diversity & equity & inclusion, mental health and well-being, and other emerging issues. The orientation is also a platform to meet and network



with fellow grantees as well as representatives of the U.S. Embassy, Fulbright alumni and organizations and institutions involved in Slovak-American exchanges and relations.

- **Pre-Departure orientation seminar** is mandatory for all outgoing Slovak grantees in order to brief them on important issues related to their departure from the U.S. and the successful completion of their grant. On November 29, 2022, the Commission held an in-person PDO meeting for grantees who did not participate in Spring 2022 and departed in January 2023. The PDO's main agenda includes the terms and conditions of the Fulbright awards, visa applications, health insurance, and financial aspects of the awards. A separate PDO was held for SUSIs participants (on May 12 and May 25, 2023) as well as for FTEA participants (on August 8, 2023). Regular annual PDO for 2023-24 grantees was held on June 26, 2023.
- **Virtual PDO meeting** for incoming U.S. grantees in Spring was held on January 5, 2023 and for those coming in the academic year 2023-24 on June 28, 2023.

#### The Mid-Year Conference

The annual mid-year conference was held on **January 26 to 29, 2023** in Trenčianske Teplice. It provided opportunity to U.S. grantees to share and exchange their experiences, present their goals and achievements, and discuss personal and professional insights with the Commission's staff. It provided the Commission with different perspectives on the Fulbright program in Slovakia in order to adopt necessary changes to improve its administration. The conference program also reflected current sociopolitical issues, and grantees had a discussion on Slovakia's role in recent development in Central and Eastern Europe with the Fulbright Slovakia alum Michal Vašečka who is a prominent Slovak sociologist.

# • The Certificate Award Ceremony

June 2, 2023 - the Commission prepared an award ceremony for all Fulbright grantees in the academic year 2022-23 to appreciate their efforts and achievements throughout the year. The ceremony was hosted by the U.S. Ambassador to Slovakia Gautam Rana at his residence.

# • EducationUSA Advising Center

The EducationUSA Advising Center of the Commission as part of the worldwide network of the U.S. Department of State provides current, unbiased, and realistic information on study programs in the U.S., counseling on all matters connected with the U.S. educational system, U.S. standardized tests, application procedures, financial aid, visa issues, etc. to the interested public. It operates daily and provides free consulting services upon appointment.

The Center supports and trains the employees of American Corners located in public libraries in Banská Bystrica and Košice. The centers are a common effort of the U.S. Department of State and U.S. embassies with the aim of providing better resources for people seeking information on the United States. The Center also serves U.S. partners and institutions as a source of information on Slovak and European higher education systems, e.g. verification and explanation of Slovak credentials, providing resources of information, etc.

Regular visits to high schools hosting ETAs are of a high importance. These visits are connected with EducationUSA outreach activities and advising services for high school students outside of the capital.

• **5 Steps To U.S. Study** - on March 8 and May 3, 2023, EducationUSA Advisor conducted in-person presentations for 23 high school students of Evanjelické gymnázium in Banská Bystrica and 34 students in Gymnázium P. Horova in Michalovce. The presentation focused on study opportunities at universities in



the U.S. and included a short comparison of the Slovak and American school system and standardized tests, and students were presented with additional options for academic exchange.

Open Advising Session - During a visit to Banská Bystrica (March 8 – 9, 2023), the EdUSA advisor, in
cooperation with the American Center in Banská Bystrica, organized a public advising session about study
opportunities and Fulbright scholarships. The event was attended by 8 people who came for consultation
and to learn about program opportunities.

**EducationUSA Regional Forum in Belgrade:** EducationUSA Advisor Zuzana Kopčanová participated in the EducationUSA Europe and Eurasia Regional Forum in Belgrade, Serbia (September 19-21, 2022) organized by the U.S. Department of State. The Forum hosted 54 advisors from 35 European countries and included a one-day professional training for advisors and a three-day conference. The professional training focused on professional development, networking activities, and sharing hands-on experiences between advisors. The conference program focused on recruitment strategies in post-pandemic times, using virtual advising, and promoting activities in the virtual environment. The conference also included a Country Fair, where advisors presented their countries and got an opportunity to talk to the HEI representatives about recruitment in their countries.

#### • Alumni

The Commission continues to cooperate closely the Fulbright alumni, especially the Slovak Fulbright Alumni Association (SFAA). Fulbright alumni assist the Commission in different ways, i.e. they serve as consultants and evaluators of project proposals, participate at orientation seminars and mid-year conferences, serve as initial connection with the host country and help grantees with different issues that occur prior (when preparing for the stay) and during their stay, and thus, help to promote the goals of the Fulbright Program. The Commission will continue to encourage alumni to participate in the events and activities of the Commission. Fulbright and Humphrey alumni are also supporting the U.S. Embassy's activities with their expertise.

Commission-supported alumni activities:

- Conference "Neurodiversity At Work" The Fulbright Commission was a partner of the conference "Neurodiversity at work" held on November 22, 2022, where ED Lýdia Tobiášová gave opening remarks together with other partners. The conference was organized by Humphrey alumna Anna Podlesná who received support from the Alumni Impact Award and in cooperation with her mentor prof. Connie Sung developed the concept of international public-private partnership (Profesia Lab). This initiative aims to bridge the disability employment gap in Slovakia by using the best practices and knowledge in the employment of people with disabilities from Michigan State University. The main objective of Profesia Lab is to improve the transition of Slovak youth with disabilities from schools to competitive employment by implementing the Assistive Soft Skills and Employment Training (ASSET program), developed by experts from Michigan State University. The conference launched this program in Slovakia.
- Alumni meeting in Košice and visits at TUKE. In cooperation with the U.S. Embassy, the Commission supported the alumni meeting in Košice on February 8, 2023. Program officer Dáša Tako Velichová attended the event.
- Women's empowerment webinar on March 28, 2023 program officer Dáša Tako Velichová organized
  a webinar on women's empowerment where she invited several Fulbright alumnae and grantees as guest
  speakers: Mária Havelková, Meredith Johnson, Kristin Tollefson, Alena Vachnová and Liliana Wurfl. They
  discussed different aspects of womens' professional life.

## Outreach

The core outreach and recruitment activities to attract prospective candidates of Fulbright awards rely mainly on virtual ads and visits to universities outside of the capital, reaching out to audiences with different backgrounds, re-connecting with alumni from different parts of the country and promoting Fulbright opportunities for



individuals as well as institutions. Based on the experience of the COVID-19 pandemic, online workshops remain an important part of the recruitment process, on which Fulbright alumni and/or U.S. universities representatives can participate easily.

**Social media** – Instagram, Facebook, LinkedIn and Youtube are crucial in communication with the interested audience. They are used to reach a broader audience, to raise awareness of the Commission's programs, activities, grantees and alumni and their impact, and the overall prestige of the Fulbright program. However, the Commission's webpage remains the primary resource and administrative tool for information and guidance on the Fulbright program's opportunities and other scholarships.

In the academic year 2022-23, the Commission and the U.S. Embassy in Bratislava continued to cooperate closely in a series of events organized either by the Commission or the U.S. Embassy:

- Meeting with American Spaces Coordinators on November 28, 2022 the Commission met with American Spaces Slovakia coordinators during their annual training hosted by the U.S. Embassy in Bratislava.
- **High school visits** the Commission conducted 6 high schools that hosted ETAs. The purpose of these visits was to check ETA performance and fulfillment, discuss any issues with their respective mentors, audit their classes, and give presentations about undergraduate studies in the U.S.:

- I Live Science Conference "I live science/Žijem vedu naživo" took place in person in Bratislava on December 20, 2022, and the Fulbright Commission participated to present research grant opportunities for participants and widen its network of contacts.
- Visit to the Technical University of Košice (February 9, 2022) Dáša Tako Velichová, a program
  officer, met with the Vice-dean of the Faculty of Aeronautics, the Vice-rector for international relations,
  and the Vice-dean of Faculty of Materials, Metallurgy and Recycling and promoted the opportunities of
  the Fulbright Program.
  - **SK-US Map of Cooperation** on January 17, 2023, the U.S. Embassy project was presented at the University of Constantine the Philosopher in Nitra. Fulbright opportunities were presented by ED Lýdia Tobiášová. On March 29, 2023 the project was presented at the University of Saint Cyril and Methodius in Trnava. Fulbright opportunities were presented by Program Officer Dáša Tako Velichová.
- **ELT MeetUps** Program Coordinator Zuzana Kopčanová presented Fulbright opportunities for English high school teachers at the ELT meetups hosted by American Spaces in Košice (May 3, 2023) and Banská Bystrica (May 4, 2023), and by the Regional Library in Žilina (December 12, 2022). Besides regional English teachers, the events were attended by ETAs and their mentors, who shared their personal experience hosting teaching assistants at their high schools.
- American Days the U.S. Embassy organized a series of American Days during the week of May 15-19, 2023 which included cities of Poprad, Rožňava, Banská Bystrica, Nitra and Trenčín. The Commission participated in events in Banská Bystrica and Nitra (May 16 and 17, 2023), where they presented Fulbright opportunities and the EducationUSA advising center.
- Scholarships and Grants to the United States (webinar) the Commission participated in a webinar organized by SAIA (Slovak focused on scholarship opportunities in the United States held on May 25, 2023. Our program coordinators presented all programs relevant to Slovak applicants, as well as programs for institutions. The webinar had 22 attendees.
- Q&A webinars on Fulbright (and SUSIs) programs introducing Fulbright program with the participation of alumni who shared their experiences: 2 webinars on FTEA Program (February 21 and March 7, 2023), 2 webinars on Fulbright Slovak Student Program (March 14 and May 17, 2023), 2 webinars on Fulbright Slovak Scholar Program (May 23 and September 13, 2023), 1 webinar on Fulbright



Specialist Program (June 20, 2023), a webinar on SUSIs for Student Leaders (on October 19, 2022) and a webinar on SUSIs for Scholars and Secondary Educators (on October 6, 2022).

## 1. The Handbook for U.S. Grantees and the Handbook for Slovak Grantees and the Emergency Plan

The handbooks and other materials for grantees are being updated each academic year. The Commission provides grantees in all programs with useful hints and guidelines on the specific requirements of each program and information of all aspects of their stay in Slovakia.

#### G. ADMINISTRATION/STAFF AND FUNDING

## 1. The Commission and the Commission's Staff

Located in the center of Bratislava, the Commission's office is easily accessible via public transportation. The Slovak Ministry of Education, Research and Sports covers expenses for space, utilities, telephone, security, and internet connection.

Active co-operation with representatives of respective governments, partner agencies and Fulbright Commissions especially in Europe have become essential for maintaining the quality of operations and administration.

The knowledge and application of Slovak, European and U.S. laws is crucial for successful administration of the Fulbright Program.

The Commission staff participate in various activities, such as professional training, seminars and conferences which focus on issues of domestic and international higher education, education at all educational levels, international policy, civil society, non-profit activities, and marketing activities.

Changes in the Staff of the Commission:

- Ms. Zuzana Kopčanová, Program officer/EdUSA advisor, ended her employment on May 31, 2023. Ms.
   Silvia Miadoková was hired as a replacement as of August 1, 2023.
- Ms. Denisa Domaracká, Financial Officer, ended her full-time employment with the Commission on August 31,2023 and will continues to provide services to the Commission as an external finance officer.
- Ms. Payton Aper (University of Michigan) has joined the Commission as Communication and social media intern for 6 weeks (June 14-July 25, 2023).

# 2. Staff Training/International Travel

Media Literacy Seminar in Warsaw, October 28-30, 2022: Fulbright Poland organized the Media Literacy
Seminar for a group of 40 ETAs from Slovakia, Czech Republic, Estonia, Latvia, Lithuania, Hungary, and
Poland. The seminar aimed to build ETA skills in media literacy and develop their understanding of
processes leading to disinformation. It was also an opportunity for ETAs to network with their peers. 3
ETAs from Slovakia participated in the seminar: Michael Griffin, Ryan McCracken, and Lauren
Whittington.



- February 28-March 4, 2023: ED Lýdia Tobiášová and current ETA Nathaniel Sansom (Rožňava) attended
  the 2023 Fulbright Seminar on the European Union and NATO held in Brussels and Luxembourg.
  Highlights of this event included visits to institutions like the European Commission, European
  Parliament, and NATO Headquarters, as well as opportunities to meet with representatives of the U.S.
  Mission to the European Union, the U.S. Mission to NATO, and the U.S. Embassy to Luxembourg.
- May 1-May 5, 2023: ED Lýdia Tobiášová attended the European Fulbright Conference in Prague and the regular European Executive Directors meeting.
- May 23-26, 2023: ED Lýdia Tobiášová attended the Global Fulbright Meeting in Washington D.C. The
  global meeting was organized ahead of the NAFSA conference for all 49 EDs in the world, including
  representatives from the U.S. Department of State, ECA, IIE and World Learning.
- May 30-June 2, 2023: ED Lýdia Tobiášová and Dáša Tako Velichová attended the NAFSA 2023 Annual Conference & Expo in Washington D.C. The conference allowed the Commission to meet U.S. colleagues and representatives of cooperating agencies and IHEs, as well as discover the latest innovations and strategies in international education. This year, for the first time in NAFSA's 75-year history, Slovakia was represented and had a Slovak National Booth at the expo. The Slovak Ministry of Education and the Slovak Embassy in the U.S hosted a national reception. In addition to Slovak participants, representatives from the U.S. Department of State, the Institute of International Education, and a few of the executive directors were present.
- May 5-7, 2023: ED Lýdia Tobiášová visited the University of Michigan, Ann Arbor's Weiser Center for Europe and Eurasia, and met with Director Geneviéve Zubrzycki and Birgitta Kohler of the University's International Office. She also met with Fulbright program advisor and scholar liaison Dr. Takata, Slovak Scholar Stanislav Zábojník of the Ross School of Business, US Scholar program alumna Zuzana Tomaš, Humphrey alum Štefan Hudec, and Amy Gillett, the Vice-President of Education at William Davidson Institute.
- Staff Training in Warsaw, Poland in July 10-12, 2023 ED Lýdia Tobiášová and a program officer Dáša Tako Velichová took part in an intensive 3-day training hosted by Fulbright Poland which brought together staff members from Poland, Czech Republic, Slovakia, Turkey, Bulgaria, and Ukraine. The workshop created a platform for the exchange of best practices in different aspects of the administration of the Fulbright program and professional networking.
- Training on Digital marketing Dáša Tako Velichová succesfully completed and obtained a certificate from a training in digital marketing. The training started in October 2022 and was succesfully completed in August 2023. The training offered 30 lectures prepared by different experts in the field, including content marketing, social media, analytics, brand marketing, graphic design, webpage design etc.

# 3. Funding

U.S. and Slovak contributions remain the main source of funding. In-kind contributions are provided through the administration of other programs and partnering with host universities and institutions.

The respective fiscal year of the Fulbright Commission is observed as set by U.S. (October 1 – September 30) and Slovak (January 1 – December 31) regulations. The financial income is composed of two sources of funding: allocation from the U.S. Government and allocation from the Slovak Government. In 2023 the Slovak government increased the allocation for the second year in a row as officially declared at the end of 2021. The increase has been used mainly for the ETA program. The Slovak government plans to reach the parity in funding in 2024.

In-kind contributions to the Commission include tuition waivers, funds allocated to other programs through other U.S. or Slovak government activities, health insurance for the grantees, private in-kind sponsorship etc.

Annually, the Commission is subject to an independent audit of receipts and disbursements and on the internal control structure. The Slovak Ministry of Education, Science, Research and Sport also audits the expenses from the Slovak government contribution separately.
